

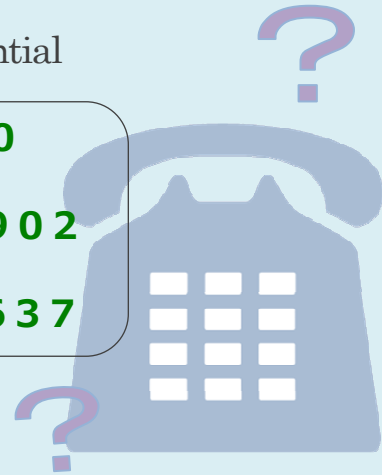
# Telephone Legal Consultation For Foreign Workers
